



Present in Syria since 1967, the ICRC is a neutral, impartial, and independent organization with an exclusively humanitarian mission. The ICRC works closely with and supports the Syrian Arab Red Crescent (SARC) to meet food, water, and health needs of people affected by the fighting in both emergencies and to help them start rebuilding their lives. They work together to raise awareness about the risks of mines and other explosive remnants.

The ICRC works to restore links between families who have been separated by the conflict and migration, visits a number of prisons, and promotes respect for international humanitarian law. It also provides advice and support to local authorities and forensics practitioners in managing human remains with respect and dignity. The ICRC's operation in Syria is one of its largest in the world, with some 850 staff working in its offices in Damascus, Aleppo, Hassakeh, Homs, and Tartous.

Over a decade on, millions of people across Syria continue to bear the brunt of a conflict compounded by several crises. Not only lives have been lost, families shattered, and homes destroyed, but people's livelihoods have been exhausted and vital infrastructure has either been damaged or destroyed, making daily essentials often taken for granted ever more challenging to obtain.

Throughout 2022, the International Committee of the Red Cross (ICRC) and the Syrian Arab Red Crescent (SARC) continued to provide vital services for millions of people. They have responded to the most pressing needs, distributed food to the most vulnerable, and supported healthcare services in communities and camps. They have also carried out repairs to critical water infrastructures and have supported hundreds of small income-generating businesses so people may start re-building their lives.

#### ENSURING ACCESS TO CLEAN WATER AND IMPROVING LIVING CONDITIONS

More than **16.5** MILLION people benefited from different water and habitat interventions across the country, as follows:

- 15 MILLION people were supported by a disinfection programme to ensure safe drinking water in 13 governorates.
- **450,000** people received water delivered by trucks in Aleppo, Rural Damascus, Raqqa, and Hassakeh.
- Nearly 140,000 displaced people and returnees benefited from renovations and upgrading of housing, water, and sanitation in 44 collective shelters and neighbourhoods throughout the country.
- 32 water facilities across the country were rehabilitated and upgraded, and eight hospitals, 62 health points, and one physical rehabilitation centre had their infrastructure improved.
- Around 710,000 people benefited from the infrastructure support to 12 public bakeries supply of production line, rehabilitation works, and power.
- The water, sanitation and hygiene facilities in over 280 schools and exam centres were rehabilitated Damascus, Rural Damascus, Daraa, Sweida, Quneitra, Homs, Hama, Lattakia, Raqqa, Deir Ezzor, and Hassakeh governorates.



#### PROMOTING AWARENESS ABOUT THE ICRC AND IHL

- Organised an all-government high-level IHL event, as well as several IHL workshops with each of the Ministry of Foreign Affairs and Expatriates-Diplomatic Institute, the Ministry of Defence, the Ministry of Interior, the Ministry of Justice, and the Bar Association, for overall more than 300 participants.
- Supported three introductory SARC IHL workshops and one advanced workshop, and facilitated the participation
  of two SARC members in an IHL course abroad and assisted the participation of SARC in the National Society
  Legal Advisers Webinar.
- Facilitated, with the Ministry of Higher Education and Scientific Research, the participation of a Syrian team in the Regional IHL Moot Court competition abroad.
- Facilitated the participation of two Ministry of Foreign Affairs and Expatriates diplomats and four Ministry of Defence officers in IHL courses abroad, as well as the participation of one Ministry of Defence officer and one Ministry of Interior official in online events.
- Organised four workshops for about 100 journalists in Tartous, Damascus, Hama and Aleppo, in addition to several meetings and sessions with over 25 journalists based in Aleppo and Damascus.
- Interacted with nearly 4,000 people across the country, introducing the ICRC and the types of activities it implements.
- Launched a couple of public and digital campaigns, including one jointly with SARC, raising awareness about the
  risks of mines/other explosive remnants of war and a campaign on mental health, and shedding the light on the
  humanitarian consequences of over a decade of conflict in the country.



#### **PROMOTING HUMAN DIGNITY AND RECONNECTING FAMILIES**

- Over 975 oral greetings and Red Cross Messages were exchanged between separated families, and more than 2,000 cases were opened by families in Syria to trace persons unaccounted for.
- More than 50 visits to detention places were conducted by the ICRC, and detainees in 10 central prisons benefited from ICRC donations of essential drugs, COVID-19 PPE, and medical equipment.
- Donated furniture and equipment to forensic centres in Aleppo, Sweida , Al-Quneitra and the forensic identification Centre in Damascus to support the forensic doctors in their daily works.
- Donated 2,200 body bags to the forensic centres in Aleppo, Homs, latakia, Sweida and Al-Quneitra, and medical
  equipment to four forensic centres in Homs, Aleppo, Damascus, and the Forensic Identification Centre in Damascus.
- Organized two workshops in Damascus on "Challenges for Human Identification" for 60 participants from the Ministry of Justice and General Commission of Forensic Medicine, and two workshops on the Management of the Dead for 60 SARC volunteers.
- Facilitated the participation of **five** high-level representatives from the Ministry of Interior and the Ministry of Health in the "World Health in Detention Conference" in Geneva, and the participation of **five** forensic doctors from the General Commission of Forensic Medicine and **two** SARC coordinators to attend **three** courses on Dead Body Management outside the country.



#### **HEALTHCARE FOR THE SICK AND WOUNDED**

- Over 447,000 people had access to healthcare services through 15 Syrian Arab Red Crescent (SARC) polyclinics and 17 mobile health units supported by the ICRC.
- More than 115,000 diabetes consultations and over 200,400 leishmaniases consultations were provided in 27 Ministry of Health facilities and Mobile Health Units across the country.
- Over 115,000 wounded and sick people, affected directly or indirectly by the conflict, benefited from emergency and
  pre-hospital care services provided by ICRC-supported SARC ambulances in 12 governorates and through 41 first aid centres.
- Over 7,000 wounded and sick persons received treatment at the ICRC-SARC hospital in AI-Hol camp, north-east Syria.
- Nearly 2,000 people benefited from the ICRC's physical rehabilitation programme in Aleppo, Rural Damascus, and Homs.
- Over 10,000 people received Mental Health and Psychosocial Support (MHPSS), and about 660 health workers were trained on MHPSS.
- Over 50 hospitals and health facilities received ICRC donations of various equipment, maintenance, and surgical consumables, with 23 of them also receiving COVID-19 Personal Protective Equipment (PPE).
- Nearly **30** hospitals and facilities benefited from ICRC donations of consumables as a response to the spread of acute watery diarrhea /cholera in parts of the country.
- Around 40 doctors and nurses from the Ministry of Health and the SARC attended the Emergency Room Trauma Course (ERTC), held in both Damascus and Homs, in addition to 30 doctors who attended the Fundamentals of War Surgery course. 20 engineers from different hospitals and directorates of health also attended a Health Technology Management Training.



## DAILY ESSENTIALS AND RESTORING LIVELIHOODS

- Over **200,000** households in **seven** governorates received food, most of them on a regular basis.
- About 170,000 households in 10 governorates received essential household items, including winter clothes, blankets, mattresses, and hygiene materials.
- About 73,000 students in nine governorates received school kits.
- Nearly 2,000 households in seven governorates including returnees, displaced families, women-headed households, and people with disabilities - received grants to initiate a small business.
- Some 29,000 people in 13 governorates benefited from local livelihood initiatives, such as the distribution of sheep, poultry, fodder, means to produce hydroponic fodder, beekeeping, fertilizers, and agricultural tools.





### PROMOTING SAFER BEHAVIOUR IN WEAPON-CONTAMINATED AREAS

- More than 230,000 people in 13 governorates attended sessions on risks related to mines/ explosive remnants of war and safer behaviour practices in weapon-contaminated areas, held by the SARC's risk education teams who were trained and supported by the ICRC.
- Over 10,000 individuals received brochures warning them about the risks of mines/explosive remnants of war, and over 980,000 individuals were reached through various social media channels with advice on how to adopt safer behaviour in weapon-contaminated areas.
- **Five** safe recreational areas were established to help affected populations mitigate the risks of weapon contamination in Aleppo, Homs, and Deir Ezzor.
- More than **200** non-technical surveys were carried out in Homs, Aleppo, Hama, Lattakia, and Idlib governorates.
- Around 50 weapon-contamination casualties were referred to various physical rehabilitation centres for assistance.
